FreshcareOnline Access Fees:

Access to the Customer Group area within FreshcareOnline, for access to grower information:

Access Level	Monthly User Rate (excl. GST)
Customer Group	\$35.50

The access fee is payable from the date that your FreshcareOnline Logon is established (usually 5-7 days after receipt of application). Access is charged for the financial year (i.e. July-June), or part thereof. For example:

- Initial access billed on establishment of logon for remainder of a financial year at \$35.50 (excl. GST) per month.
- Ongoing, access billed at the start of each financial year (12 months) at \$426.00 (excl. GST).

Access fees will be invoiced once your application has been received and processed, and your FreshcareOnline Logon will be established following payment of fees.
